The Town was going to use Limestone in place of stone. Limestone lasts longer and is cleaner. It is more expensive in the short term but less expensive in the long term. The Town Highway will haul the stone.

The board was asked the board to consider the purchase of a wood chipper which would convenience the town crew at times they are trimming trees. After some discussion the board made a verbal denial of the request if it were to be made formally. No vote was taken. The board suggested that a chipper be rented when needed.

Announced that the new employee had been hired. The starting pay will be \$12.00 per hour.
