Supervisor Reynolds Greeted Don Baker and invited him to ask any questions. Don asked for a explanation of the tentative budget. Lois explained the budget process and told Mr. Baker that a budget will be available in the clerk's office for public review latter in a short time. Mr. Baker had no comments.

Superintendent Reniff reported they had 5 thousand ton of gravel from the River that would require crushing. He presented 2 quotes for the crushing. The Board reviewed these reports and after a short discussion tabled the proposals.

John Francisco asked about the Back River Road repairs. This project has not been started yes.

A discussion regarding the need to crush rock and when it would be needed started again. No decisions were made. It was suggested this crushing of rock would be included in next years (2012) budget.

The board reviewed the 2012 budget. A discussion followed. No decisions were made.

Supervisor Reynolds spent time explaining what the assist accounts meant. She explained the 2012 budget was \$7,207 under the tax cap.

Board went over the budget line for line. Clerk Winterhalter explained the need for a grant writer to write a grant request to electronically archive the Town's records. Also explained was the need to back up the Clerk's computer and the Bookkeepers computer on the internet. Also explained about the decrease in the Deputies salary in order to increase the Clerks Salary.

Supervisor Reynolds asked if any changes were needed.

No decisions were made and no vote was taken.

Lois Reynolds asked for a vote to accept the union contract as it stands. A role call vote was taken
