TITLE: LOCAL LAW # 1-75

A LOCAL LAW TO PROVIDE FOR THE PUBLICATION OF A SUMMARY STATEMENT OF THE TEXT OF ADOPTED ORDINANCES IN LIEU OF THE PUBLICATION OF THE ENTIRE TEXT THEREOF.

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF AMITY, AS FOLLOWS:  
HENCEFORTH, ANY LAW TO THE CONTRARY NOTWITHSTANDING, ALL ORDINANCES DULY ADOPTED BY THE TOWN OF AMITY IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK, AND WHICH MUST BE PUBLISHED IN A NEWSPAPER AS REQUIRED BY LAW TO RENDER SAID ORDINANCE EFFECTIVE, MAY BE PUBLISHED IN SAID NEWSPAPER BY THE PUBLICATION OF A SUMMARY STATEMENT OF THE TEXT OF SAID ADOPTED ORDINANCE, IN LIEU OF THE PUBLICATION OF THE ENTIRE TEXT THEREOF, AND BY PUBLICATION OF A NOTICE STATING THAT THE WHOLE OF SAID ORDINANCE IS ON FILE WITH THE TOWN CLERK OF THE TOWN OF AMITY, AND FURTHER PROVIDED THAT A COPY OF SAID WHOLE ORDINANCE IS KEPT ON FILE WITH THE TOWN CLERK OF THE TOWN OF AMITY DURING THE PERIOD OF SAID PUBLICATION. NOTHING HEREIN CONTAINED SHALL DISPENSE WITH ANY POSTING OF SAID ORDINANCE WHICH IS OR MAY BE REQUIRED OR PERMITTED BY LAW.

THIS LAW SHALL TAKE EFFECT IMMEDIATELY.
