A local law providing a four (4) year term for the elective office of Town Clerk of the Town of Amity.

- Section 1. The term of office of Town Clerk for the Town of Amity shall be four (4) years. Such four (4) year term to commence on the first day of January following the first biennial town election after the effective date of this Local Law, which shall be January 1, 2012.
- Section 2. Commencing with the term of office of Town Clerk, beginning January 1, 2012, and every four (4) years thereafter, the Town Clerk shall be elected for a four (4) year term.
- Section 3. This Local Law shall supersede, in its application to the Town of Amity, section 24 of the Town Law of New York State with respect to the term of office of Town Clerk. This Local Law is enacted pursuant to section 24-a of the Town Law of New York State.
- Section 4. This Local Law shall be submitted for approval of the electors of the Town of Amity at the next general election to be held November 2, 2010.
- Section 5. This Local Law shall take effect immediately upon filing with the New York State Secretary of State, after approval by a majority of electors voting thereon in accordance with the requirements of section 27 of the Municipal Home Rule Law of New York State
